I. U.S. ORIGINATING TRANSBORDER UNITED STATES CHARTERS (TUSC)

#### 1) LEGISLATIVE REFERENCES:

Part IV, Sections 76 to 78(1) of the Air Transportation Regulations (ATR)

Part IV, Division V, Sections 103 to 103.5 of the ATR

#### 2) CARRIER MUST HOLD:

Non-Scheduled valid for charter operations between Canada and the

International licence: United States

**Insurance certificate:** adequate insurance coverage pursuant to section 7

of the ATR

**Operating certificate:** must reflect aircraft type to be used for the operation

(this document is issued by Transport Canada)

#### 3) CARRIER REQUIREMENT:

A charter that originates in the United States and that is destined to Canada shall be operated in accordance with the rules and regulations of the United States. The carrier must have received permission from the aeronautical authorities of the United States for the charter.

#### 4) PRIOR NOTIFICATION:

Prior Notification is required for aircraft having a maximum certificated take-off weight (MCTOW) greater than 35,000 lbs.

An air carrier operating a charter that originates in the United States shall notify the Agency in writing **not less than 48 hours** before the date and time of the arrival in Canada of the charter or, in the case of a series of charters, the date of the first of those charters, with the following information:

- a) the name or the charter category of the charter under the rules and regulations of the United States;
- b) the name, address, telephone and facsimile numbers of each charterer;
- c) every airport of enplanement or point of departure and every airport of deplanement or point of destination of the charter; including each airport proposed to be used by the air carrier;
- d) the dates and times of arrival and departure of each charter; and

e) the aircraft type and, where applicable, the passenger seating capacity and the nature, quantity and total weight of goods to be carried for each charterer on each charter.

### 5) OPERATIONAL RESTRICTIONS:

No U.S. air carrier shall operate a TUSC flight or series of TUSC flights for a courier service using aircraft having a MCTOW greater than 35,000 lbs serving more than one point in Canada on a single flight.

- Canada Border Services Agency regarding the availability of clearance services and hours of operation of the port of entry (General Inquiries in English 204-983-3500 or 506-636-5064).
